Important Notice

Signature and Chop on Vehicle Registration Document (VRD)

The VRD has to contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD has to contain the signature of an authorized representative together with a company/organization chop and the chop on the application form must be identical with that on the VRD, otherwise this department will not process the licensing application.

Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [Please refer to the list of acceptable proof of address]

Change of Address

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address in writing, through <u>GovHK</u> or by submitting <u>the specified form</u> ("Change of Personal Particulars or Vehicle Particulars").

Submission of Identity Document

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

Applicant may choose to provide his completed application form and relevant documents to Licensing Office (LO) via email (hklo_reg@td.gov.hk) for preliminary vetting. Under normal circumstances, TD will provide a reply through email within 10 working days informing the applicant of the result of preliminary vetting; and advise the applicant to formally submit the original application form together with supporting documents and prescribed fee to an LO through the submission means mentioned in the application form. TD will only conduct preliminary vetting on applications submitted by email, and such applications will only be formally processed and approved after receiving the original application and supporting documents from applicant.

If you are a registered elector and your residential address has changed, please notify the Registration and Electoral Office (REO) as early as possible. For enquiries, please call the REO hotline 2891 1001.

(二)車輛課税

- (1) 登記的車輛如屬汽車(首次登記税)條例(香港法例第330章)規定的應課税車輛,車主必須填寫本表格「車輛課税」部分。
- (2) 買車時的汽車售價/所付款額總數應包括買車時所有材料、工程的成本、配件及保證的價值,經紀/代理/手續費等,但不應包括首次登記稅。

(三) 第三者風險保險

任何人(包括登記車主及司機)在道路上使用汽車,有責任確保有關汽車已購備有一份有效的第三者風險保險單。假如有關人士違反此規定,即屬犯罪,可被處罰款 10,000 元及監禁 12 個月;而其持有或領取駕駛執照的資格亦會被取消(由 12 個月至 3 年不等)。運輸署署長可拒絕發出有關車輛牌照或取消該車輛牌照。

(四) 以支票支付未繳付的交通罰款

有關車輛牌照的申請,如申請人曾以支票支付未繳付的交通罰款,運輸署會在以支票付款日七個工作天後,才辦理有關申請。

(五) 法庭命令

若有法庭命令指示運輸署署長拒絕向你簽發車輛牌照,則運輸署署長無權向你簽發有關牌照。

(六) 更改個人或車輛資料

your Hong Kong Identity Card or a passport for non-identity card holders in the case of a private owner (Note: A private owner must be aged 18 years or above); In the case of a company, the Certificate of Incorporation/Certificate of Registration of Non-Hong Kong Company/Certificate of Change of Name/Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company must be produced (Business Registration Certificate will not be accepted);
Original or photocopy of valid Third Party Risks Insurance Policy or Cover Note;
Business Registration Certificate for registration of a Taxi, Private or Public Light Bus, Private or Public Bus;
invoice or payment receipt of vehicle manufacturer or car distributor;
sales contract or purchase order of the vehicle concerned;
Notification of Motor Vehicle Provisional Taxable Value issued by the Customs and Excise Department and/or other relevant documentary proof in connection with vehicle taxation which may be required;
Published Retail Price List approved by the Customs & Excise Department, if applicable;
Type Approval Certificate or Certificate of Roadworthiness issued by the Transport Department;
Certificate of Retention of Registration Mark, or a receipt for payment of the auction price of the registration mark and memorandum of sale, or the notification letter of allocation of the registration mark, if applicable;
(Applicable to vehicles which require pre-registration inspection) Documents inspected by the Vehicle Safety and Standards Division during the vehicle pre-registration inspection. If the vehicle has been registered outside Hong Kong, the applicant/registered distributor shall produce the vehicle log book/registration document or certification of vehicle de-registration issued by the overseas authorized organization. If the vehicle has never been registered outside Hong Kong, the applicant/registered distributor shall produce (i) certification issued by the authorized organization at the exporting place indicating that the vehicle has never been registered, (ii) supporting documents showing that the vehicle was directly acquired by the registered distributor/importer from the manufacturer for sale, or (iii) declaration made by the vehicle importer under the Oaths and Declarations Ordinance (Cap. 11) stating that the vehicle has never been registered outside Hong Kong. Where the above documents are in a language other than Chinese or English, a translation prepared by a qualified person is required;
Original or photocopy of proof of present address (residential address/company address and correspondence address) which is issued not more than 3 months from now (includes utility or telecommunication bills, documents issued by banks, insurance companies, government departments, local universities, international charitable organizations or charitable organizations registered in Hong Kong). 2. VEHICLE TAXATION

- (1) If the vehicle being registered is liable to tax in accordance with the provisions of the Motor Vehicles (First Registration Tax) Ordinance (Cap. 330), the information required in the part 'VEHICLE TAXATION' of this form must be given.
- (2) The selling price/full price paid for the purchase of the motor vehicle should include the cost of all materials and works; value of accessories and warranty; and brokerage/agency/handling fee etc. in the purchase of the motor vehicle and exclude First Registration Tax.
- (3) Provisional Taxable Value assessed for any of the items by the Customs & Excise Department should be declared if there is no Published Retail Price.
- (4) Optional accessories declared under Item (ii) refer to those which are not fitted to a standard motor vehicle at the time when the vehicle is offered for sales; but which may be fitted to the vehicle for an additional payment.
- (5) The declaration should be signed by:
 - (a) the registered distributor or a person authorized by the former; and
 - (b) the person applying for first registration, being either the purchaser of the motor vehicle or the importer of the vehicle where he is not a registered importer.

3. THIRD PARTY RISKS INSURANCE POLICY

Any person (including the registered vehicle owner and driver) has the responsibility of ensuring the presence of a valid third party risks insurance policy for the vehicle concerned whilst using it on roads. Person who contravenes such requirement commits an offence and is liable to a fine of \$10,000 and imprisonment for 12 months, and will also be disqualified from holding or obtaining a driving licence (for a period of 12 months to 3 years). The Commissioner for Transport may refuse to license the vehicle concerned or cancel the vehicle licence concerned.

4. SETTLE OUTSTANDING TRAFFIC FINES BY CHEQUE

If applicant has used cheque to settle payment of outstanding traffic fines, application for licensing a vehicle would only be processed after 7 working days from the date of cheque payment.

5. OUTSTANDING COURT ORDERS

The Commissioner for Transport is not empowered to issue any vehicle licence to you if there are any outstanding Court orders directing the Commissioner for Transport to refuse to issue the said licence to you.

6. CHANGE OF PERSONAL OR VEHICLE PARTICULARS

- (1) If a **change occurs in the name, address, e-contact means or identity document** of a driving licence holder/registered vehicle owner previously provided to the Commissioner for Transport, he or she shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of the change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. For cases of change of name or change of identity document, he or she shall also deliver to the Commissioner for Transport the following documents for amendment, including original copy of the existing driving licence, driving instructor's licence, vehicle registration document, vehicle licence and Certificate of Allocation of Personalized Registration Mark, if applicable;
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** and may suspend the processing of the application until the production of such proof. Therefore, applicants please bring along proof of present address for presentation as and when requested by officers of licensing offices; and
- (3) For any change of address notified in this application form, all vehicle/driving licence records of the applicant under the same identity document no./Certificate of Incorporation no./Company Registration no. held by this Department will also be changed.
- (4) If there is change of any entry in the registration document and vehicle licence relating to the vehicle (e.g. colour, engine no. etc.), the registered vehicle owner shall submit a duly completed Transport Department Form TD559 together with the required documents stated in the form to notify the Commissioner for Transport of such change.

7. E-CONTACT MEANS

Registered vehicle owners must provide either a Hong Kong mobile phone number or an email address as the e-contact means when submitting vehicle licensing applications. If both Hong Kong mobile phone number and email address are provided, the email address would be adopted as the e-contact means. Please refer to the "Notes About Your Personal Data" for the purposes of collecting e-contact means and the class of transferees. In particular, the Transport Department, other Government departments, bureaux and Toll Service Provider may issue electronic notification to you through the e-contact means provided by you, either by SMS or email, as and when necessary (e.g. a toll payment notification may be issued by the Toll Service Provider through the e-contact means when toll cannot be successfully made by automated payment where your vehicle passes through a tunnel implemented with Free-Flow Tolling System).
