Important Notice

Signature and Chop on Vehicle Registration Document (VRD)

The VRD **has to** contain signature of the registered vehicle owner, and the signature on the application form should match with that on the VRD when a relevant licensing application is submitted by the registered vehicle owner concerned. If the vehicle is owned by a company/organization, the VRD **has to contain** the signature of an authorized representative together with a company/organization chop and the chop on the application form **must be identical** with that on the VRD, otherwise this department will **not** process the licensing application.

Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [Please refer to the list of acceptable proof of address]

Change of Address

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address in writing, through <u>GovHK</u> or by submitting <u>the specified form</u> ("Change of Personal Particulars or Vehicle Particulars").

Mail items with insufficient postage

Underpaid mail items are subject to surcharge by Hongkong Post. This department will not accept underpaid mail items, which will be returned to the sender (with return address) or disposed of (without return address) by the Hongkong Post. For proper delivery of your mail items to the department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage with return address before posting. [Please note the latest details about postage rates by Hongkong Post]

Submission of Identity Document

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

Applicant may choose to provide his completed application form and relevant documents to Licensing Office (LO) via email (hklo_reg@td.gov.hk) for preliminary vetting. Under normal circumstances, TD will provide a reply through email within 10 working days informing the applicant of the result of preliminary vetting; and advise the applicant to formally submit the original application form together with supporting documents and prescribed fee to an LO through the submission means mentioned in the application form. TD will only conduct preliminary vetting on applications submitted by email, and such applications will only be formally processed and approved after receiving the original application and supporting documents from applicant.

If you are a registered elector and your residential address has changed, please notify the Registration and Electoral Office (REO) as early as possible. For enquiries, please call the REO hotline 2891 1001.

For cases of change of name or change of identity document, the driving licence holder/registered vehicle owner shall also deliver to the Commissioner for Transport the existing original driving licence (if applicable), original driving instructor's licence (if applicable), original vehicle registration document (if applicable), vehicle licence (if applicable) and Certification of Allocation of Personalized Registration Mark (if applicable) for amendment.
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** (residential/company and correspondence address, e.g. water/electricity/gas/mobile phone bill or bank correspondence), and may <u>suspend the processing of the application</u> until the production of such proof. Applicants please bring along your proof of present address which is issued not more than 3 months from now for presentation as and when requested by officers of licensing offices.
- (3) For any change of address notified in this notice, all vehicle/driving licence records of the applicant under the same identity document/ Certificate of Incorporation held by this Department will also be changed.
- (4) Copy of your submitted supporting document(s) will be destroyed after processing your application.

退回有效車輛牌照費 REFUND OF UNUSED VEHICLE LICENCE FEE

Copies of the Schedule are available for inspection upon request at each Transport Department's licensing office. Arrangement for the refund would be made on receipt of your notification of cancellation of the vehicle registration and you would be informed by the Treasury for that refund.
